Executive Meeting Minutes September 22nd, 2010

Mascot - Prina

- Pass on to VP engagement
- Adrian set out a list of rules to Johnny (first person to wear the mascot)
 - Things not to do while wearing the mascot, to protect our brand
- At POITS, the mascot can wear just a shirt and suspenders as business casual
- List of things being looked at by manufacturer
 - Suspenders: The manufacturer will send them for no cost
 - The battery fell out, so we were suggested to hot glue the battery back in. Battery life is about 4 -5 hours.
 - Heavy head has a fan and tends to be front heavy. The manufacturer doesn't suggest using clips to clip to the undergarment
 - Beefier arms will cost \$200 – Which is still in our budget
 - An extra tie will be purchased
 - Maintenance: After Imagine Day, the mascot was not taken care of well, so we want to find an oversized hanger. Clean the shoes after wearing the mascot.
 - Executive needs to find a way to unleash the mascot other than POITS

Merchandising & T-Shirts - Moses

- Spreading the Sauder spirit through merchandise – Sauder spirit is lagging, a lot to do with the construction of the building

- Why not provide these people something else for free (other than a clipboard), we could give out stickers so that people recognize the “CUS” spirit, or a T-shirt
- Allows people to recognize fellow Sauder students

- Connor: What people liked about the CUS is the free coffee and the free newspaper, so although the conferences are great. We have looked into ties, scarves, pins, grad rings, stickers... etc.

- Jesse: To elaborate, the money spent isn't entirely on the conferences, it also goes to clubs and it's spread out in a way so that the money is still beneficial for people who don't attend the conferences. We also have a variety of services offered; one of the issues may be a lack of awareness.
- Moses: If you went out to ask students what the CUS has done for them this year, there is no tangible evidence
- Jeff: Having T-Shirts is a great idea to build a sense of spirit. Do you know how much this would cost us?
- Moses: \$10.00 a person
- Connor: It would cost \$15,000 to buy everyone a tie
- Jeff: I think we should focus more on the awareness of the services we offer
- Paulina: I have to second Jesse's point. We have a lot of stuff in our offices which needs to be given away
- Connor: We have allocated \$10,000 only to give away stuff
- Sharlene: I am going to reactivate the account for newspapers
- Moses: Do we have enough giveaways to give to each of our students, in order to provide something to unify us
- Prina: After looking at FROSH costs, T-shirts are about \$6-8
- Niki: We want to make sure what we order is something that people actually want to wear the giveaways. Other faculties wear their clothing
- Connor: Last year we didn't spend the whole funds of \$266.00

CIVC – Ethan

- We need to create a press release and address what happened, resulting in Ethan being appointed as chair.
- So far the press release has the following points:
 - A release for sponsors, and one for students
 - Reasons around why Khalil was dismissed
 - Reasons around Rob's exit from the BOD
 - Venue changes
 - Anything involved with hotel
 - External delegates involved
 - Different stakeholders that were mentioned
 - The professionals that were contacted previously, the sponsors, the students and the professionals that are flying in

- Jeff: What exactly will you say about these topics and how you will communicate

- Paulina: I don't know if it's a good idea to have alternating press release
- Jesse: It's okay if all the same points were made

 - Sherman from food services – We are going to meet to see how he can accommodate our needs with the cafe
 - We will be letting people under 19 into POITS, I suggested to get rid of some of the stuff in the rooms, so people can have something to drink and we can get rid of it
- **Jesse:** Going to talk to candidates tomorrow before elections so that they are honest

In-camera Discussion

Alberta Energy Challenge & ExCo

- Group found out about a conference 6 weeks in advance, however the policy in ExCo is that you have to apply 6 weeks in advance
- By the time they applied, they no longer could receive ExCo funding.
- Last year they went and paid out of their pocket because ExCo didn't reimburse them for the money
- These people aren't very familiar with the CUS and these guidelines
- The conference was the Alberta Energy Challenge – and they kept all their receipts from the competition
- Jeff: The cost came out to be about \$3500 for five people. If we had the choice at the beginning to the year, Kin said not to fund because it's a new competition. I believe we can subsidize the students this one time.
- Paulina: By doing this, we wouldn't be setting a good precedent
- Connor: The exec funds separately from ExCo. It comes from the special projects fund. In the past we have paid groups after the competition
- Jeff: The competition isn't very prestigious
- Connor: I think 50% of travel costs, or an X number per person is fair. They essentially spent 400 per person for travel. Would we feel comfortable reimbursing by \$200 each?
- When we sent a team to Lincoln Nebraska, we sent about \$250 a person. With JDC West, the CUS takes care of almost \$500 for each attendee.
- Connor: Next year if someone applied to this, could we justify this?
- Jeff: Jordan's team could have approached us for the funds with a breakdown, and we could have someone experienced with specific competitions who can determine if this is a good conference.
- Niki: They were honest about their
